## Urbean Cafe

Our award-winning workforce development program, **Urbean Cafe** has contributed more than \$7.5 million to the local economy since 2011, saved taxpayers more than \$3.5 million, and given 145 clients meaningful work (2024).

Employees give back to the community through stable employment, housing, utilities, transportation, and insurance. They pay restitution, including fines, court costs, and child support. And, they contribute to federal, state, and local income taxes.



## Lydia's Home

*Lydia's Home*, our six-bed Certified Level II Recovery Residence for women in the City of Green, helps women recover from substance abuse and incarceration. Lydia's Home is our practical and spiritual response to the illegal opioid, fentanyl, and methamphetamine crisis in Ohio.

Lydia's Home residents experience a formalized substance abuse recovery program. This includes a 60-day curriculum-based Life Formation Study Series, financial literacy training and accountability, and workforce readiness and GED preparedness.



## Mentoring & Bible Study

Our *mentoring and bible study* programs share God's love with returning citizens and connect them with faith communities.

- Mentoring is essential. Having a trusted mentor helps restore a sense of personhood. A study by Barna Research, Prison Fellowship, and New York University found that most former offenders who are mentored will not commit another crime.
- We have served thousands of individuals in cooperation with the Summit County Judicial System, law enforcement, government leaders, churches, foundations, healthcare providers, and community partners.
